## TERMS AND CONDITIONS

The **Pledge Tuition Rate** will be split evenly between the fall and spring semesters, rounded to the nearest whole dollar. The Pledge Tuition Rate is assessed every fall and spring semester in which the Student is enrolled [full-time](#) while classified as an undergraduate student. Students enrolling [less than full-time](#) will be charged a prorated per credit hour rate based on The Pledge Rate. The Pledge Tuition Rate is not paid in semesters in which Student enrolls in no classes. If Student's campus changes during the rate term, the tuition rate for the applicable campus will be assessed.

The Pledge Tuition Rate specified previously (FOR THE ON-LINE VERSION) covers only Northern Arizona University's base tuition for the fall and spring semesters. Student is responsible for and shall pay, in addition to The Pledge Tuition Rate, all mandatory and class fees, any special fees such as for Study Abroad, and all program and college based tuition, whether now existing or approved in the future, all at the then-prevailing rate. The Pledge Tuition Rate does not include summer and winter terms. Student agrees to pay all tuition and fees applicable to summer and/or winter programs for which Student is enrolled.

The Pledge Tuition Rate is not applicable to excess credit hours as defined by Arizona Revised Statutes §15-1661. Student agrees to pay as separate and additional tuition, all tuition and fees applicable to excess credit hours.

**Payment** Student shall pay the Pledge Tuition Rate as billed on Student Accounts using one of the available payment options. Past-due accounts are subject to normal late fees and the withholding of university services, for example registration and graduation, and are subject to assignment to a collection agency.

**Financial Assistance** Student remains eligible for all financial assistance offered by Northern Arizona University. Student's eligibility for financial aid is not affected by participation in The Pledge Tuition Plan.

Participation in the Pledge Tuition Plan will not increase any financial aid offered to Student. However, the Student's budget for financial aid purposes will reflect The Pledge Tuition Rate instead of the tuition rate in effect at the time for Continuing Students.

Financial assistance programs are based on the number of credit hours for which the Student enrolls. However, Student shall always pay the full-time Tuition Rate on an annual basis when enrolled [full-time](#). Financial aid eligibility will be based on the actual number of enrolled credits which may be less than full-time study, but Student will be responsible for paying the full-time Tuition Rate.

**The Pledge Rate Term** The Pledge Tuition Rate is for [full-time](#) enrollment. Continuous enrollment is not required; however, interruptions in enrollment (whether due to, for example, medical withdrawal, mission service, or study abroad) do not extend the Pledge rate term. Students who need a ninth or tenth semester to complete their degree will pay the same Pledge Tuition Rate as the class which entered the university the year after them. Students returning after an interruption in enrollment of two (2) or more semesters will pay The Pledge Tuition Rate in effect at the time they return and will have eight (8) consecutive semesters to complete their degree. Students returning after a one (1) semester interruption will continue to pay their Pledge Tuition Rate; however that semester of non-enrollment will count as one semester of the rate term.

**Termination and Refund.** If Student withdraws, any refund of tuition paid shall be subject to normal policies governing refunds.

**The Pledge Tuition Plan** In the event there is any inconsistency between these Terms and Conditions, the [Pledge Program](#) will prevail.
